- 9.2 Parking Services Update: Andy Rampersad (Assist. Director Operations from Parking dept)
- 9.2.1 Beginning July 1 we are going from physical permits to license plate that is the parking credential.
- 9.2.2 Will go into portal, register vehicle
- 9.2.3 Physical tags eliminated
- 9.2.4 3 options to consider:
- 9.2.4.1 Annual parking (365 days) fee (valid from date of transaction). Goes for calendar year.
- 9.2.4.2 150 days permit (again from day of purchase)
- 9.2.4.3 Daily permits
- 9.2.4.3.1 \$8 parking fee pilot for 24 hours.

9.2.4.3.1.1 4 garages are assigned no overnight parking, as well as on downtown campus. 24-hour passes will not work there.

- 9.2.4.4 Doing this in phase approached.
- 9.2.5 Vendor permits, bulk passes, Retail Employees will still have physical pass/permits
- 9.2.6 Each account holder may register 2 vehicles for additional \$15 fee. Only one of the vehicles may park on a campus at time. Will need to do a temporary change online to change tag number.
- 9.2.6.1 If you have a new tag issued, just go to parking services, and let them know.
- 9.2.6.2 Staff members that are students, are required to purchase a staff permit.
- 9.2.6.3 Signs will still read "B", "C" even though these are now electronic.
- 9.2.6.4 Vanity plates are not permitted at this time for back in parking

9.2.6.5 Handicap tags are permitted in any handicap space, is not specific to lot and they are also permitted in metered parking for 2 hours.

- 9.2.6.6 Motorcycles must have their own pass.
- 9.2.6.7 If you have current hang tags purchased for guests, etc, they will continue to work.
- 9.2.6.8 No longer option for physical tags.
